The history of Nürnberger Lebkuchen

Lebkuchen-Tradition in Nürnberg

It was in 1409 that the word Lebkuchen was first mentioned in a Franconian manuscript. The oldest existing written Lebkuchen recipe originates from the sixteenth century.

The original simple medieval recipes became more and more developed, as evidenced by the "Complete Nürnberg Cookbook" from 1691.

Honeycutters and Lebkuchen-bakers



In the fifteenth century, beekeepers or honeycutters collected honey from woodland beehives in the Reichswald forest just outside Nürnberg. As Nürnberg was located at the intersection of several famous trade routes, bakers had access to all manner of exotic spices. It was from these ingredients, together with honey and nuts that the first Nürnberg Lebkuchen originated. Even in these early days, it was held in such high esteem that in 1643, the Lebkuchen bakers left the bakers' guild to set up an association of their own.

Protected origin

Since 1996, the designation "Nürnberger Lebkuchen" has enjoyed legal protection as a geographic designation of origin, and is thus recognised throughout Europe. The most important requirement to be allowed to carry the famous name is manufacturing within the city limits of Nuremberg.





Lebkuchenguide for Connoisseurs

The exact composition of the Lebkuchen-dough is, of course, both then and now a well kept secret.

But the basic ingredients remain the same: **Eggs, flour and honey. Hazelnuts, almonds and walnuts. Candied orange and lemon peel** and – essential for the taste – the spices: **aniseed, ginger, coriander, cloves, pimento, mace, cardamom and cinnamon.**

Oblaten-Lebkuchen are “Lebkuchen of a special kind”. To retain their distinctive taste, high quality and purity, the Lebkuchen-bakers undertake a voluntary, but strict set of controls. To ensure the correct taste they stick to the traditional standards, which exactly dictate the composition of the different kinds of Oblaten-Lebkuchen.



Chocolate with 70% cocoa:

For all Lebkuchen and pastries which are coated with dark chocolate we solely use high-quality chocolate with an especially **high cocoa content of 70%**. The term is **dark chocolate**..



Premium Eisen-Lebkuchen:

They are the “Premium Product” amongst the Oblaten-Lebkuchen. The masses must contain a **minimum** of 25% almonds and/or hazelnuts and/or walnuts and **maximum** 10% cereal flour is allowed. According to the guidelines for fine bakery products the masses – also called doughs – are spread onto the wafers and are baked after a slight drying of the surface. Afterwards the Lebkuchen are refined with chocolate or sugar icing.












Fine Oblaten-Lebkuchen:

This variety contains **not less than** 14% of nuts and kernels 50% thereof are almonds and/or hazelnuts and/or walnuts.

Soft Gingerbread:

These include all types of Lebkuchen which are formed, rolled or cut out and not baked on wafers. They are produced with or without oilseeds. Lebkuchen with this designation, i. e. without an indication of oilseed contents, may contain **no more than** 3% added fat in relation to the flour content.

Terms and conditions of contract and delivery



Section 1 General - Scope

1. The conditions of sale of Gottfried Wicklein GmbH & Co. KG - hereinafter referred to as the „Supplier” — apply exclusively; conflicting or deviating conditions of the purchaser will not apply unless this is expressly agreed in writing. These conditions also apply if the Supplier undertakes delivery to the purchaser without reservation in the knowledge of contrary or deviating conditions of the purchaser.
2. All agreements made between the Supplier and the purchaser for the purpose of performing this contract are set forth in writing in this contract.
3. These conditions of sale apply only to companies within the meaning of Section 31a para 1 BGB (German Civil Code).

Section 2 Offers

1. If an order is to qualify as an offer within the meaning of Section 145 BGB, then the Supplier can accept that offer within two weeks.
2. The Supplier's offers are subject to change. The option of prior sale is expressly reserved.

Section 3 Prices and payment

1. Unless otherwise provided in the offer or order confirmation, the prices of the Supplier „ex works” including packaging apply.
2. In determining the price, what is crucial is the weight/quantity of the goods as at the time of dispatch, as well as and the prevailing prices of the Supplier's own suppliers and the exchange rates, customs and import fees. The Supplier reserves the right to change its prices if, after conclusion of the contract, or cost increases occur, especially due to labour contracts, changes in material prices, the prices of upstream suppliers, changes in exchange rates, or changes in customs and import fees.
3. Statutory VAT is not included in the prices; it is given on the invoice separately at the statutory rate applicable on the invoice date.
4. The application of discounts is allowed only after special written agreement thereto.
5. Unless stated otherwise in the order confirmation, the purchase price is payable in full within 14 days of the invoice date. The legal regulations concerning the consequences of late payment apply.
6. Offsetting rights exist for the purchaser only if its counterclaims have been legally established, are undisputed or have been recognised by the Supplier. The purchaser is entitled to exercise a lien only if his counterclaim is based on the same contractual relationship.

Section 4 Delivery and performance obligations, shipping, transfer of risk, transport costs

1. Delivery and performance times are binding. Unless otherwise provided for in the offer or order confirmation, delivery shall be „ex works”.
2. The minimum order value for a purchaser's unloading point in Germany is € 500,-.
3. Compliance with the delivery obligation requires the timely and proper fulfilment of purchaser obligations. The defence of lack of performance of the contract is reserved.
4. If the purchaser is in default of acceptance or culpably violates its other duties to cooperate, the Supplier is entitled to demand compensation for the damage incurred by then Supplier in the matter, including any additional expenses. Further claims are reserved.
5. If the requirements of Point 3 above have been met, the risk of accidental loss or accidental deterioration of the goods passes to the purchaser at such time as the latter is late with regards to acceptance or payment. Otherwise, risk is passed on (even for partial deliveries) upon each delivery of the goods by the Supplier to the freight forwarder, carrier or to any other person or institution commissioned with executing the shipping.
6. Unless otherwise agreed in writing, the means of transport and route are the choice of the Supplier.
7. There will be no redemption of transport and other packaging according to the packaging ordinance.
8. Partial deliveries and partial performance are permissible if they are reasonable in the view of the purchaser. The requirement for correct and timely delivery remains.
9. Insofar as circumstances for which the Supplier is not responsible impede or delay the fulfilment of accepted orders or make them impossible, (e.g. transportation delays and/or bottlenecks, acts of God, strikes, lockouts, official interventions, energy or raw material shortages or involuntary hindrance to operations, e.g. through fire, water or and machine damage), the Supplier is entitled to postpone the delivery, what is left of the delivery or the partial delivery for the duration of the hindrance, or to completely or partially withdraw from the contract without the purchaser being entitled to claim for damages. In the event of one of the cases mentioned above, the purchaser's respective obligations will also cease to apply. The above rules also apply when these events occur at a time when the Supplier is behind schedule.

Section 5 Warranty

1. Warranty claims of the purchaser assume that the latter has properly fulfilled its obligation under Section 377 HGB (German Commercial Code) with regards to inspection and complaints. The delivered goods must be inspected immediately and competently for defects, condition and assured characteristics by sampling at least 1% of the goods sent. Obvious defects must be reported immediately following delivery by written notice. Hidden defects which were not initially discovered despite the duly completed obligations regarding inspection and complaints must be reported in writing immediately after the defects are noted. The Supplier has the right to itself inspect defective goods at the purchaser's premises. The purchaser must handle the goods properly and store them in an appropriate manner. In addition, it is obliged to mitigate the damage.
2. If there is a defect in the purchased goods, the Supplier is entitled to choose whether its subsequent performance will take the form of repair or of delivery of new, defect-free goods.
3. If there is a failure in the subsequent performance, the purchaser is entitled to choose to demand withdrawal or reduction. Other warranty claims are excluded.
4. The limitation period for warranty claims is 12 months from the transfer of risk.
5. The limitation period and the expiration date in the case of delivery recourse pursuant to Sections 478, 479 BGB remains unaffected, and amount to two and five years respectively.

Section 6 Retention of title

1. The Supplier retains ownership of the goods until receipt of all payments relating to the purchase contract. In the case that the purchaser breaches the contract, in particular with regard to defaulting on payment, the Supplier is entitled to reclaim the goods. The retrieval of goods does not constitute withdrawal from the contract, unless this is expressly stated in writing. Seizure of the purchased goods by the Supplier will always constitute a withdrawal from the contract. Following the retrieval of the purchased goods, the Supplier is entitled to dispose of them, with the sale proceeds being deducted from the purchaser's liabilities, minus reasonable costs.
2. The purchaser is obliged to handle the purchased goods with care; in particular, it is obliged to insure the goods for their replacement value and at its own expense against fire, water and theft.
3. In the event of seizures or other interventions by third parties, the purchaser shall notify the Supplier immediately in writing, so that action under Section 771 ZPO (German Code of Civil Procedure) can be taken. If the third party is not able to reimburse the Supplier for the judicial and extrajudicial costs of an action under Section 771 ZPO, the purchaser will be liable for the losses thus caused.
4. The purchaser is entitled to resell the purchased goods in the ordinary course of business; however, it hereby assigns to the Supplier all claims to the amount of the final invoice (including VAT) of the Supplier's claim which come to the purchaser from the resale against its customers or third parties, regardless of whether the purchased goods have been resold without or after processing. The purchaser remains entitled to collect this claim even after the assignment. The Supplier's authority to collect the receivables itself remains unaffected. However, the Supplier undertakes not to collect the claim as long as the purchaser meets its payment obligations from the collected proceeds, is not in default of payment and there is no application for opening of insolvency proceedings or a suspension of payments. If this is however the case, then the Supplier may require that the purchaser discloses the assigned claims and their debtors, provides all information necessary for collection, hands over the relevant documents and informs the debtors (third parties) of the assignment.
5. If the purchased goods are inseparably mixed with other items not belonging to the Supplier, then the latter will acquire joint ownership of the new item in proportion to the value of the goods (final invoice amount including VAT) to the other processed items at the time of mixing. If the mixing is such that the purchaser's item is to be regarded as the main item, it shall be deemed agreed that the purchaser will transfer proportionate co-ownership to the Supplier. The purchaser will retain the resulting sale ownership or co-ownership for the Supplier.
6. The Supplier undertakes to release the securities due to it at the request of the purchaser insofar as the realisable value of the securities exceeds the claims to be secured by more than 10%; the choice of which securities are to be released will be the Supplier's.

Section 7 Foodstuffs policy/Privacy policy

1. If samplings are performed by government or other authorities, then the Supplier is to be immediately presented with a copy of the report of the sampling and the test results and a contrasting sample taken if appropriate.
2. The purchaser agrees that the relevant data for order processing and sales statistics may be stored and processed in accordance with the legal provisions.

Section 8 Written form, severability clause, jurisdiction, place of performance, applicable law

1. Verbal ancillary agreements to this contract do not exist. Changes or additions to the contract will be effective only if agreed in writing.
2. If any provision of this contract is or becomes invalid, this will not affect the validity of the remaining provisions.
3. If the customer is a merchant, the legal venue is the Regional Court of Nürnberg-Fürth. However, the Supplier is also entitled to sue the other party at its head office.
4. Unless the order confirmation/order requires otherwise, the place of performance is Nürnberg.
5. Our business partners undertake not to pass on the data made available in connection with the commercial relationship to unauthorised third parties, and to safely protect and store the data from access and misuse by unauthorised persons.
6. German law applies to the exclusion of international private law and to the exclusion of the UN Sales Convention (CISG).
